i. Most of the pages of tender documents has not signed by authorized person. (Refer page no. 9-270)

B. Forms /Annexures

i. Annexure V (affidavit regarding sister concern organization):- Not acceptable Refer page no. 7, which shows that bidder has given self declaration on Rs 100 non-judicial stamp. This is not as per the RFP (Annexure V) where it has clearly mention that bidder has to submit notarized copy of this declaration on Rs 100 non judicial stamp.

C. Technical eligibility / Mandatory / other Criteria

- Minimum 8 Years Experience in organic Certification (NPOP & NOP):- No Refer page no. (80-109), where bidder has submitted 14 scope certificates for NPOP certification issued for year 2008, 2009, 2011, 2013, 2014, 2015, 2016, 2017, 2018, 2020, 2021. Bidder has not enclosed any scope certificate of NOP certification.
- ii. Affidavit regarding blacklisting (Annexure VI) :- Not acceptable

Refer page no. 8, which shows that bidder has given self declaration on their letter head. This is not as per the RFP (clause 3.2-ix) where it has clearly mention that bidder has to submit an affidavit on Rs 100 non judicial stamp from notary.

No any accreditation certificate / Scope certificate / any sub-contracted documents regarding the inspection has enclosed in support of their claim.
