Objective

Organic agriculture is production of agriculture products free from chemicals and pesticides residue by adopting eco-friendly low cost technologies,"Pramparagat Krishi Vikas Yojna (PKVY)" is an elaborated component of Soil Health Management (SHM)of National Mission for sustainable Agriculture(NMSA). Under PKVY, organic farming is promoted through adoption of organic village by cluster approach and PGS certification.

Organic Area Selection Criteria:

- a) The cluster chosen for organic farming shall be 50 acres in extent and in as contiguous a form as possible. In order to facilitate this, the ceiling of subsidy that a farmer is eligible shall be for one hectare and the total financial assistance eligible for a 50 acre cluster shall be maximum of Rs.10 (Ten) lakhs for farmer member and Rs.4.95 for mobilization and PGS Certification. Of total number of farmer in cluster, a minimum of 65% farmers should belong to the marginal and small categories. Thus minimum criteria of inclusion should as far as practicable be fulfilled at cluster level and when not possible, it should be satisfied at Mandal/Block/Taluka or District level.
- b) Organic farming shall be promoted in such areas like hilly, tribal and also in rainfed areas where utilization of chemical fertilizers and pesticide is less.

Eligibility Criteria

- 1. The NGO's / Organization should be registered as Service provider /Regional Council under National center of Organic farming(NCOF) as well as under the Firms & Societies Act (document be attached). Registration must be at least 5 year old (as on 01-12-2016).
- 2. The agency/Organization should have minimum o5 years of experience (as on) in ICS management, Group certification of organic progress (NPOP/PGS India) and Marketing of Certified Agriculture product (Certificates be attached).
- 3. The Government organization should enclose copy of appointing authority of CEO as well as Secretary of the Organization to prove that it is a Govt. agency. In absence of above, the proposal will not be accepted.
- 4. The agency must be capable to market/ make_market linkages og organic certified products with proven track record in similar field(clearly specify).
- 5. Preference will be given to the agencies having processing/ Value addition and marketing background of organic products (Proof be attached)
- 6. The Agency should have a local office in Jharkhand otherwise they will have to open an office in the district if selected (given address).
- 7. The annual turnover of the organization for the last three financial year should not be less than Rs. 50 lakhs, and copy of audited Balance sheet and ITR for last three years should be attached with proposal.
- 8. Staff position should be such as either already endowed or be in a position to deploy appropriate staff. Staff must be qualified in agriculture background and know the local language & should be aware with Organic farming activities.
- 9. The agency should be competent to train the farmers, "Lead Resourceful Person (LRP)" and carry out awareness Programmes of National standards/ PGS standards and must have sufficient technically qualified and highly competent staff with vast experience in organic inspection and certification activities.
- 10. The agency should be familiar with government development programs/ projects and be in a position for dovetailing with those programmes/ projects.
- 11. The agency should not be Blacklisted anywhere in India and should submit affidavit in this regard.

Terms and Conditions

- 1. The bids will be scrutinized by a committee, who will have the right to shortlist the agencies based on the requirement. The selected agency shall be invited to make power point presentation before the committee.
- 2. The selected agency shall within 10 days of having been called by notice will sign a MOU with the OFAJ.
- 3. The scheme will be implemented in selected 7 districts covering 150 clusters of Jharkhand namely Ranchi, Ramgarh, Hazaribagh, Saraikela kharsawan, Deoghar, Khunti and Sahebgang.
- 4. After selection the issuance of work order will be decided by Chief Executive Officer OFAJ and shall be final in all aspects.
- 5. The agency must facilitate by back of Organic products and shuld be capable to market /make market linkages of organic certified products.
- 6. As the process of certification of organic products takes conversion period of three years thus it is quite possible that many of farmers / group of farmers may quit organic farming after the conversion period. Hence, it is necessary that service provider will provide all

- necessary assistance to farmers even after the lapse of conversion period for minimum two years.
- 7. All the related technologies (i.e organic production, certification, value addition, marketing of organic products etc) should be efficiently transferred to the farmers / Group of farmers by the service provider before handing over period.
- 8. If the agency fails to meet the objective, Conditions, Quality parameters of PKVY norms the agreement will be void. The agency will be black listed and appropriate action will be taken.
- 9. Programs must be implemented for adoption of organic farming and getting organic certification under PGS system and marketing of organic products of all crops.
- 10. Quality parameters should be adhered to input supply (such as Organic manure, Biofertilizers, Biopesticides, Biocontrol agents, Seed and planting material etc.) and service provided.
- 11. The off-farm inputs used in selected organic area must be organically certified.
- 12. An Ernest money worth Rupees 1.00 lakh shall be deposited by the agency in the form of demand draft at the time submitting proposal.
- 13. The agency shall submit a bank guarantee of the amount involved while entering in to the MOU with the OFAJ. The agency shall also require to attach the bank guarantee in prescribed proforma of the concern bank.
- 14. The amount of implementation of PKVY is to meet
