### Objective:

Organic agriculture is production of agriculture products free from chemicals and pesticides residues by adopting eco-friendly low cost technologies, "Paramparagat Krishi Vikas Yojna(PKVY)" is an elaborated component of Soil Health Management (SHM) of National Mission for Sustainable Agriculture (NMSA). Under PKVY, Organic Farming is promoted through adoption of organic village by cluster approach and PGS certification.

The purpose of this initiative is to engage the organizations or agencies registered with NCOF for successful implementation of PKVY Scheme by extending their expert help collectivize organic farmers, mobilizing farmers for organic cultivation, their group formation registration etc., imparting them with organic crop production trainings in close association with the agriculture department, building their capacities, helping them for preparing different types of reports, online registration of farmers, organic cluster formation, training and capacity building for farmers, technology introduction, support to farmers in induction of technological adoption, creating different types of reports for getting organic certification from PGS India for organic producers at various levels across several areas, to foster technology penetration, improve productivity, enable improved access to inputs and services and increase farmer incomes and thereby strengthening their sustainable agriculture based livelihoods by converting their farms and fields for organic cultivation, The second part of the intervention involves linking producer groups directly to market aggregators to enable integration of the agriculture value chain and bring agriculture produce through capable market aggregators directly to consumers.

### Procedure for Implementation of Project:

Organic Farming under Paramparagat Krishi Vikas Yojna (PKVY) will be implemented based on the principle of Cluster Approach and Certification of Participatory Guarantee system of India (PGS). It will be implemented and valid for three years period after allocation of work. Government of India has approved Annual Action Plan for the implementation of PKVY scheme for Jharkhand state. Based on this approval, Agency is to be selected for the implementation of the project

### Scope and Expected Outcome

- Promotion of commercial organic production through certified organic farming.
- The produce will be pesticide residue free and will contribute to improve the health of consumer
- It will raise farmer's income and create potential market for traders
- It will motivate the farmers for natural resource mobilization for input production

### Minimum Eligibility Criteria :-

- The Agency / Firm / Organization should be minimum five years old as on 01-01 2018. (Enclose registration certificate)
- ii. Agency having minimum 5 years experience in organic field under NPOP / PGS (Participatory Guarantee Systems) programme. (Enclose scope certificates)
- iii. The agency having minimum 1 year experience in marketing of certified produce (NPOP/PGS) or the Producer / farmer /grower's group has marketed the certified produces under their certification services (Enclose Transaction Certificates)
- iv. The agency should have a local office in Jharkhand otherwise they will have to open an office in Jharkhand after getting the work order.
- v. The agency should be registered for GST (Copy of certificate enclosed )
- vi. Agency / firm must have the PAN No. (Copy enclosed)
- vii. Average annual turnover of last three financial year's (2014-15, 2015-16, 2016-17) should be not less than 25 Lacs.
- viii. Audited balance sheet along with IT return should be submitted for the last three financial years (2014-15, 2015-16 & 2016-17).
- ix. The agency should have got work order for PGS/NPOP certification programme from at least two states.
- x. Agency should never been blacklisted / de-accredited earlier by any state or union government and non-affiliation with any political / religion / govt endowment. (Affidavit on Rs 100 non judicial stamp must be enclosed)
- xi. The Agency will have to submit EMD of Rs 5.0 Lacs in form of Demand Draft in the favour of Chief Executive Officer, Organic Farming Authority of Jharkhand, Ranchi.
- xii. The Government organization should enclose copy of appointing authority of CEO as well as secretary or Head of the organization to prove that it is Govt. Agency. In absence of above, the project will not be accepted.

#### xiii. Desirable Criteria :-

- a. Experience in inspection & certification of organic projects at International level. (Attach Proof with supporting documents).
- b. Experience in Paramparagat Krishi Vikas Yojna (PKVY) programme under any state or union govt. (Attach proof with supporting documents).



### **Terms and Conditions:**

- 1. The agency should have competent and technically qualified staff with experience in organic implementation or certification process. Staff should be familiar with local language.
- 2. The office should be equipped with computer, printer & internet facility.
- 3. At least one member is well versed with data handling & uploading in computer on internet.
- 4. The bids will be scrutinized by a committee, who will have the right to short list the agencies based on the requirement. The selected agency may be invited for making a power point presentation before the team of experts.
- 5. The successful agency shall, within 14 days of having been called by notice, execute a formal agreement on stamp paper worth Rs. 500/- and the cost shall be borne by the successful bidder
- 6. The scheme will be implemented in selected 5 districts (Ranchi, Ramgadh, Hazaribagh, Saraikela, & Deoghar) covering 150 clusters of Jharkhand State.
- 7. After empanelment the issuance of work order will be decided by the Chief Executive Officer, Organic Farming Authority of Jharkhand and shall be final in all respects
- 8. As the process of certification of Organic products takes conversion period of 24 months, thus it is quite possible that many of farmers/group of farmers may quit organic farming after the conversion period. Hence it is necessary that "Agency" will provide all necessary assistance to farmers/group of farmers (for Grading, Packing, Labeling, Branding, Value addition & Marketing of certified organic produce/product) even after the lapse of conversion period, and such assistance will be for minimum one year after the conversion.
- 9. All the related technology (i.e. Organic production, Certification, Value addition, marketing of organic product etc.) should be efficiently transferred to the organic farmers/ group of farmers by the Agency before handing over period.
- 10. If the agency fails to meet the objectives, conditions, quality parameters of PKVY Norms the agreement will be void. The agency will be black listed and payment cut or penalty will be imposed.
- 11. Programmes must be implemented for adoption of organic farming & getting organic certification under PGS system and facilitating in marketing / market linkage of organic produce of all /selected crops.
- 12. The agency shall submit a bank guarantee of 5% of the amount involved while entering into MoU with OFAJ.
- 13. Agency who has experience in organic farming in Jharkhand.
- 14. Chief Executive Officer, Organic Farming Authority of Jharkhand reserve the right to accept or reject any or all application without giving any explanation. Further, the undersigned also reserves the right to accept/ reject/ modify any or all proposals without assigning any reason thereof.
- 15. In case of any dispute the decision of Chief Executive Officer, Organic Farming Authority of Jharkhand will be final and the jurisdiction shall be Ranchi only.

### Role and responsibility of empanelled agency / Regional Council

- i. Training and support to existing and new local groups in procedures and paperwork necessary for each farmer's organic guarantee.
- ii. Translate and print PGS paper work in local language
- iii. Register local groups and issue user ID and password for data uploading on PGS India website.
- iv. Facilitate local groups in data uploading on PGS website
- v. Confirms that the local group summary worksheet listing that all the farms that are to be certified organic is and was conscientiously maintained by the group.
- vi. Cannot pick or choose individual farmers to certify, only approve/confirms the collective decision of the Local Group as a whole and organic integrity of the system adopted by the local group.

  (Ideally once a local group summary sheet with collective decision of the group signed by at least three lead members is endorsed by the RC, the RC activates the UID. On UID activation the group can directly print the certificates of all its members, but in case if the group does not have access to computer and internet then the same will be facilitated by RC)
- vii. Activate and/or issue certification UID number to each approved Local Group (received from the instant UID Pool maintained on PGS Website).
- viii. Print and distribute annual Organic Certificates for individual farmer
- ix. Participate in sampling of Local Group farm appraisals
- x. Participate in online system to provide summary worksheet information to interested parties and helps to connect interested parties with the Local Groups for access to individual farmers" Organic Guarantee
- xi. To facilitate Mutual Recognition and Support for the various groups (and individual farmers) on a national level by allowing Regional Councils to audit the Organic Guarantee of certified farms in other Regional Councils.
- xii. To quickly build trust and credibility in the system as a whole ensure access to members of the public and media.
- xiii. Submission of annual reports on PGS activity in a prescribed format to NCOF
- xiv. Organize sufficient training to farmers on organic farming activity, assist in annual action plan preparation, packing, marketing, logo preparation, transportation etc.,
- xv. Residual analysis and Soil testing of samples through NABL labs
- xvi. Assist farmers/LGs to upload data relating to PGS activity in PGS web-portal



### Guideline for submitting the proposals:

#### A. General guideline

The interested agency are required to submit the proposal as per the guidelines and formats detailed out in the following paras:-
