FINAL PROCEEDING FOR EMPANELMENT OF BIO-INPUT MANUFACTURER'S

With Reference to EOI $\{PR\ No.\ 219811(Agri)19-20D\}$ for input manufacturer's has evaluated by technical committee members on 27^{th} Dec 2019 and evaluation report has uploaded of web portal of OFAJ on 3^{rd} Jan 2020 where we have asked from the bidder to submit their grievances or objection on this evaluation report within 7 days if any.

One agency International Panaacea Ltd (IPL) has submitted their grievances on 10^{th} Jan 2020 where on covering letter head they have mention it on dated 1^{st} Jan 2020. OFAJ has uploaded evaluation report on public domain dated on 3^{rd} Jan 2020 then how bidder has given explanation on 1^{st} Jan 2020.

Application of IPL has rejected on certain clause mention in Section A & Section C (i, ii & iii) in earlier evaluation report which has approved by technical committee members on 27th Dec 2019

IPL has submitted their grievances on total six points where bidder has submitted hard copy of supporting documents (228 pages) directly to OFAJ office on 10th Jan 2020. Now OFAJ will not accept or consider these documents for evaluation purpose because technical committee members can only re-evaluate those documents which bidder has submitted during the submission of EOI proposals.

IPL has submitted grievances on following points where after re-evaluation of EOI documents findings are mentioned here as:-

Section A:- Still non-conformities are open because no any grievances has submitted by bidder on this clause

Section C

i. NPOP attestation certificate :-

Remark: While Re-evaluation of bidder's documents technical committee members has found that Bidder has submitted only one year NPOP attestation certificate which has mention on page no (41-44 & 254-257)

So whatever technical committee members has evaluated earlier that was found correct.

ii. Minimum 8 years experience in manufacturing of organic farm input:-

Remark:- While Re-evaluation of bidder's documents technical committee members has found the justification which bidder has given are irrelevant.

Manufacturing License is only applicable for CIB/FCO products which can't claim regarding the integrity and credibility of organic inputs under NPOP standards. Manufacturing of organic farm input under NPOP requires NPOP attestation certificate from any NAB/APEDA accredited inspection and Certification agencies.

Bidder has submitted one NPOP attestation certificate which has issued on 12th Dec 2018. So we can only consider the experience of manufacturing of organic farm inputs accordingly. (Refer Page no. 41-44 & 254-257)

iii. Minimum 8 Yrs experience in marketing of organic farm inputs:-

Remark:- While Re-evaluation of bidder's documents technical committee members has found that whatever decision has given earlier that was correct.

As per documentary evidence it shows Organic farm input has manufactured since Dec 2018. So any experience for marketing of organic products should be considered only after Dec 2018.

Audited Balance sheet:-

Remark:- While Re-evaluation of bidder's documents technical committee members has found that bidder has submitted provisional balance sheet which committee members has already accepted. Refer Conclusion of earlier evaluation report where it's clearly mention.

Moreover Bidder's application has not rejected on the basis of this clause.

ITR for A.Y 2019-20

Remark:- While Re-evaluation of bidder's documents technical committee members has found that bidder has not submitted the ITR for AY 2019-20. OFAJ has not rejected bidder's application on the basis of this clause.

vi. Product test / Trial report from SAU/other Govt. Institute

Remark:- While Re-evaluation of bidder's documents technical committee members has found that bidder has not submitted any trial/test report which has issued by SAU/Government organization. It was consolidated report self prepared by IPL. So whatever technical committee members has evaluated earlier that was found correct. (Refer page no. 206-247)

OFAJ has not rejected bidder's application on the basis of this clause

Application of IPL has rejected due to non-conformities which were still observed after reevaluation of EOI documents which has mention in point :- A & C (i, ii & iii)

On the basis of re-evaluation of EOI documents, technical and evaluation committee members has rejected the proposal of International Panacea Limited and finally decided to empanel three agencies for the supply of organic farm inputs in Jharkhand. These three selected agencies are:-
