### FINAL PROCEEDING FOR EMPANELMENT OF CERTIFICATION AGENCIES

With Reference to EOI {PR No. 219813(Agri)19-20D} for certification agencies for organic certification of horticultural or agricultural produce in Jharkhand has evaluated by technical committee members on 27<sup>th</sup> Dec 2019 and evaluation report has uploaded of web portal of OFAJ on 1<sup>st</sup> Jan 2020 where we have asked from the bidder to submit their grievances or objection on this evaluation report within 7 days if any.

One agency ADITI Organic Certifications (P) Ltd has submitted their grievances on 2<sup>nd</sup> Jan 2020 on following points

- i. Serial number of documents are not arranged as per EOI  
**Remark:-** While Re-evaluation of bidder's documents technical committee members has found that bidder has not arranged the documents as per the EOI Guideline and whatever technical committee members has mention earlier in evaluation report that was found correct.  
Bidder has mention that as per application form they have arranged the documents but application form is also a document which has mention in Guideline and in Guideline it's clearly mention how to arrange all documents in given serial order. (Refer last page of EOI)
- ii. Minimum 8 years experience in organic certification  
**Remark:-** Bidder has already accepted that they have submitted scope certificates which has issued since August 2012 to 2019 which our technical committee members has already mention on earlier evaluation report.  
EOI has floated on 12<sup>th</sup> Oct 2019. So this is the reference / cut off date for considering any previous experience. So Since August 2012 to Oct 2019 shows 7 years 3 months experience only.
- iii. Affidavit:-  
**Remark:-** Bidder has already accepted that Xerox copy of affidavit has submitted in spiral way and original copy has handover separately.  
As per EOI guideline for submission of proposal kindly refer clause A (point no. 3) where it's clearly mention that all documents must be spirally binded and pages must be numbered. So we can't accept any other document which is not spirally binded and not arranged serially with page number system. Xerox copy of affidavit can not be accepted.
- iv. DPR (Detail Project Report)  
**Remark:-** Bidder has given justification in different way which is Digitalization on Organic produce value chain which they have mention in annexure 20.  
As per EOI guideline for submission of proposal kindly refer clause C (ii), where we have clearly mention that bidder has to submit a proposal about how the present given job shall be accomplished in jharkhand and also mention about the preference of area of operation in the project proposal. For this we have asked bidder to submit DPR which has mention in enclosures list (Refer SI No. 15 of last page of EOI).





These two selected agencies are:-


